You may wonder whether that kind of insight would not lead to complete lawlessness as we actually are already seeing in the country. Would it not make the legal system even more complicated than it already is?

I don't think so but rather it might bring about some humility among some of the Justices sitting on the U.S. Supreme Court. They might question their denials of appeals which override lower courts and might experience some self doubt, an emotion with which they are not familiar. It could be the beginning of true wisdom and the end of harsh sentences, the end of the death penalty.

So why hasn't this happened, you ask, after all these women and men have gone to university and law school and will along the way have heard the above quote? I don't have the answer to that except to say that man/woman does not appear to do well with absolute power. Yes, I know there is that other quote: "power corrupts and absolute power corrupts absolutely" but in closing let me just say that I am very comfortable knowing that I know nothing! So perhaps I am wise after all and if nothing else this maxim certainly helps us not to take ourselves too seriously as most of us tend to do!

In the land of Dixie flags and monuments erected to preserve the very best of its racial heritage, the powers that be have it all figured out. Their justice system is flawless. Their prison system is not overcrowded, nor is it riddled with violence. The Department of Justice is just picking on them. Their execution protocol works perfectly. Especially since no one knows what it is, and they get to make it up as they go along. Capital punishment is a deterrent. Wrong! Capital punishment is justice for the family, that will also bring them closure. Wrong! When the family stands against such "Supposed" justice in their name's they are ignored. Capital punishment is nothing more than a political tool mixed with revenge... Oops, that just slipped out. Sound bites, smoke and mirrors, rhetoric... it's political season. Murder is murder. All life is sacred. Except when votes are needed. This state stands with domestic violence victims...whether they want to or not, or unless they need the perpetrator on their payroll.

Imagine, he knows this is it, SCOTUS turned down his last appeal at around 5:24 pm and he was lead to the murder chamber for the state of Alabama as "justice." to begin. His mind and strength fortified to help endure his state sanctioned murder. What he was not fortified for was the horrendous 3 hour torturous ordeal he was about to be subjected to. Poked, exploded veins! Prodded, exploded veins! Attempted cut downs, bloody, pain, grimacing, busted skin from straining against straps, and finally sedation. What could possibly go wrong?

What everyone keeps alluding to is that he was back there with no attorney present, but everyone is missing the fact that he was his own representation. Which means, not only did the DOC torture Joe Nathan James Jr. to death, but in doing so they violated his due process rights when they sedated him and he was not allowed to nor able to contact the court to inform them that the execution was being botched horribly. Then there's the question of how or why they couldn't find a vein?! When an execution date is set they take the person to medical to locate the vein they will be using during the execution. In Mr. James' case they last checked for a vein when they took him to medical for a physical on July 26th, 2022, two days prior to his torture. What happened to those veins? What could go wrong?

Let's talk about why a man is his own lawyer but couldn't use the phone to stop this when everyone that knows him knows he would fight to the end. How about asking why he was put under sedation? To stop him from representing his own self on his own behalf while they subjected his body to human torture. Then the state of Alabama calls this justice in the name of the family - which was asking to spare the life of Joe.

We have to really rethink things and who we are putting in power by our choices in voting. People please wake up before it; s too late.

Dear brothers on Alabama's Life Row,

Many times in the course of my work I've been asked why it is that I clearly have a special interest in capital punishment and the lives of those condemned to die. In most cases, I ignore the question. But when one of you reached out to ask me why it is that I prioritize you in the work that I do, I felt inclined to answer.

I haven't written a general explanation of my work on capital punishment thus far because my experience has shown me that there's not really much use in explaining myself to strangers; people aren't inclined to change their minds, and what I do ought to speak for itself, anyhow. Worse, often when I am faced with this particular question it is in fact posed as an underhanded accusation. People will say, for instance, "why are you so obsessed with killers on death row?" to suggest there are better, worthier subjects of concern in the world. Some will then go further, implying that any interest must be a product of feminine delusion, misguided sympathy, stupidity, sentimental obsession, and whatever profanity. To me, the ideas contained in these accusations -- the notion that there are human lives that are worth more than others, and the notion that defending the equal value of life constitutes perversion -- are both clearly evil and obviously false, though corruption can obscure a person's view of the world, as I read Titus: "To the pure, all things are pure, but to those who are corrupted and do not believe, nothing is pure."

To me, the case for concern about the lives of people on death row is very straightforward. For one thing, you are all - to a person -- human beings. I think that means something spiritually, cosmically significant. I think that humankind is unique in nature and history, and that human consciousness is a mysterious, sophisticated, perhaps holy thing for which the universe seems especially prepared. In my religious tradition, Catholicism, we explain the uncanny splendor of humankind by looking to the image dei, the image of God according to which each person is made. That each person bears the image of God also implies that each person belongs to God (the coin face in Matthew 22 bears the image of Caesar, and so it belongs to Caesar, Christ says; but what image is drawn upon the human body, other than that of God?) and has within them an indestructible goodness, and therefore, the capacity for redemption. Every life is precious, and no one is beyond hope.

But while my moral and political beliefs both militate against capital punishment, I don't think anyone need share my moral reasonings to share my political reasoning. In terms of policy, capital punishment is one of the worst we routinely enact. From the backward logic of Baze, where we learn a defendant must provide a superior method for his own execution if he is to successfully challenge his state's, to the rank unfairness of death-qualified juries, which are more likely to accept prosecutors versions of events and to convict in the first place, to the overt reality that one's life often depends on whether one can afford good lawyers at trial -- it seems difficult to me to come up with a legitimate way to describe any aspect of capital punishment as fair or democratic. So much comes down to prosecutorial discretion and capricious plea bargaining, or to whether the defendant is black or the victim was white, or whether the underlying crime happened to take place on one side of a state line or the other. Further, a certain but

sporadic flow of savegely botched executions has revealed that the death penalty, in America, is really two penalties in one: First, one is convicted to die; second, one is convicted to participate in a lottery of torture before they're granted the privilege.

Some proponents of capital punishment acknowledge all the above complaints but argue that there are potential policy solutions that could affect a fairer and more just death penalty. While I don't dispute that there are elements of the criminal justice system that need reform, neither do I think that efforts to kill our own citizens in a more rational style make much sense as a use of time or money. America has traditionally lagged behind our peer nations in key matters regarding human rights, including the abolition of slavery, and I view our late, dreadful attachment to the death penalty in that same vein, it simply isn't an institution worth saving.

And I believe I owe that instinct to the Golden Rule: Do unto others as you would have them do unto you. It is easy for people to imagine themselves as the victims of crimes, but hard to imagine themselves as the perpetrators of them, rightly or wrongly accused. I suspect this makes it hard for them to empathize with others in the way the Golden Rule requires a person to. But I am not so certain of myself — I've fucked things up and changed over time, and also fucked things up and stayed the same over time; I know what I would want in either condition. I know what I would want if I were condemned to die. I would want someone to care about it, and somebody to notice that it was wrong, and to behave as though — despite all messages to the contrary — I was still a human being. And you are, and so am I.

#### Miscarriage of Justice

The definition of a miscarriage of justice, according to the Oxford dictionary, is a failure of a court or a judicial system to attain the ends of justice, especially the one that results in the conviction of an innocent person. Due process is a legal requirement that the state must respect all legal rights that is owed to a person it balances the power of the law of the land and protects the individual person. According to the United States Constitution you have a right to legal representation even when that representation is yourself.

The state of Alabama carried out the legal murder of Joe Nathan James Jr. on July 28th, 2022 in an illegal manner. Mr. James himself was his own legal counsel.
